She joined the company in 2000 in the project management team, where she was responsible for tram projects for Polish clients, including municipal enterprises in Warsaw and Szczecin. As the production competences of Alstom in Poland were developing, Beata was responsible for the transfer of the technology for producing railway rolling stock components. In the following years, she gained extensive managerial experience in various positions in Poland (bidding, tender documentation, accounting, financial analysis and controlling), as well as at the Alstom unit in La Rochelle in France where she cooperated with international team in tram projects.
